

PRIVACY POLICY

GREENATOPIA Corp, located in Paseo Tulum and Retorno Edzna Mz. 19 Lte. 8 Local 45 Playa Car Fase II Playa del Carmen, Quintana Roo, zip code 77717, recognizes the importance of protecting the personal information you provide and offers this Privacy Policy, to which you should refer to fully understand how we collect and use personally identifying information, in compliance with Mexico's **Federal Law on Protection of Personal Data Held by Individuals** (from now on, "the Law".)

Your Personal Information

Personal information is collected only when knowingly and voluntarily submitted. For example, this information may be provided when you request specific data, subscribe to our services or newsletters on our website (www.greenatopiarealestate.com), make a transaction with us (for example, buy, sell or rent a property), or when you are offering your professional services.

The personal information voluntarily submitted includes:

-Contact information, such as name, age, marital status, place of birth, personal address, date of birth, personal ID number, phone number (landline or cellphone), fax, email.

-Academic information, such as studies, degrees, professional license number, area of expertise, certificates.

-Work information, such as occupation, company you are working in, job title, business address, email, phone number (landline or cellphone) and fax.

-Billing information, such as name of the entity that will make the payment, taxpayers' address, RFC (Mexican code for paying taxes.)

-Financial information, such as bank accounts information, preferred payment method and personal preferences.

-Legal and commercial information, such as matrimonial regime, salary, income and monthly expenditures, credit bureau reports and background checks, properties owned, documents about trials the person may have faced.

How Is The Personal Information Used

The personal information voluntarily submitted (for example, when sending an email to request specific data or when registering to our newsletter), will be used to contact you in order to answer your inquiries and send the appropriate response.

The personal information obtained when making a transaction (such as buying, selling or renting a property) will be used to carry out that operation, to perform credit checks in case you are interested in obtaining a loan or payment terms, to provide you with information that you request

from us, to send invoices, to hire services or buy products offered by you, to make payments for those services or products, or to draw up contracts or other documents to formalize a business transaction.

Sharing Personal Information

GREENATOPIA Corp will not sell, share or transfer your personal information to third parties outside this organization without your permission. However, we may share your personal information with third parties only in the ways that are allowed by the Law.

Security

GREENATOPIA Corp takes all reasonable and appropriate steps to protect the security and integrity of all personal information provided to us against damage, loss, alteration, destruction, use, access or undue disclosure. However, no method of transmission over the Internet, or method of electronic storage, is 100% secure, and due to this fact, GREENATOPIA Corp cannot guarantee that your personal information is entirely safe from damage, loss, alteration, destruction, use, access or undue disclosure. Only authorized employees who have been trained to respect the confidentiality of the personal information submitted by you can have access to your data.

Your Rights
